TERMS AND CONDITIONS OF AGREEMENT

Customer also agrees to pay Digital Documents, as interest, an amount equal to 1 1/25 per month, or provided by law (whichever is less) for invoices that are past due. Should customer default on any such payments(s), Digital Documents shall have the right, without notice to Customer, to declare all invoice amounts due and payable. In the event Digital Documents should commence any action or actions, or otherwise seek to enforce this agreement against Customer or any Guarantor, Customer agrees to pay reasonable attorneys fees, court cost, and other expenses incurred by Digital Documents, whether or not a suit is filed. This agreement is not transferable or assignable without prior written consent from Digital Documents. Customer agrees that any change in any debts incurred by Customer to Digital Documents due to change in Customer's form of business, shall not be effective as to Digital Documents until Digital Documents receives actual notice of the change by certified mail. This agreement shall become effective when Digital Documents written acceptance is received by Customer. This agreement is entered into, and shall be governed and construed in accordance with the laws of the State of California. By execution hereof, Customer agrees to be subject to the jurisdiction of the courts of the State of California.
